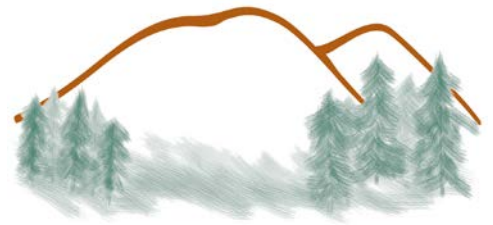

## Camp Tamarancho Reservation Refund Policy

(weekend campsite use)

All REFUND requests must be made in writing to [staff@boyscouts-marin.org](mailto:staff@boyscouts-marin.org) by email or US Mail.

FULL refunds will be granted only if:

- The reservation is cancelled by the Marin Council or Camp Ranger due to severe weather conditions or other facility use issues determined by the Camp Ranger and Scout Executive.
- The cancellation by the group is at least 30 days in advance of the start of the reservation.

PARTIAL refunds will be granted:

- If cancelled less than 30 days prior to the reservation but more than 14 days before the reservation start. Groups cancelling in this time period for any reason will be granted a 75% refund upon request.
- Cancelling because of bad weather:
  - If a group cancels within 14 days of their arrival in camp because of foul weather, they must notify the Camp Ranger or Marin Council office prior to their scheduled arrival. Failure to notify will be treated as a "No-Show", and no refund will be granted.
  - If a group decides to cancel based on bad weather, the following refund policy applies:
    - Cub Scout Packs or Family campouts: 75% refund
    - Webelos Den Campout: 50% refund
    - Scouts BSA troops and Venturing BSA crews: 25% refund

NO refunds will be granted for cancellations within 14 days of your arrival in camp for any reason other than stated above.
